1. This Act may be cited as the Definition of Time Act.

- Standard Time.
- The Standard Time to be observed throughout Belize for all purposes whatever, save as hereinafter provided, shall be the mean time of Longitude ninety degrees West, which is seven minutes, seventeen seconds and twentyseven hundredths of a second later than the mean time at Belize City and six hours later than Greenwich mean time.
- The Minister responsible for Home Affairs may from time to time by Minister may Order published in the *Gazette* prescribe that the local time in Belize shall vary local time. 40 of 1963. 22 of 1973.

5. Nothing in this Act shall affect the use of Greenwich mean time for purpose of astronomy, meteorology or navigation or affect the construction of any document mentioning or referring to a point of time in connection with any of those purposes.
