SOUTH AUSTRALIA { Proclamation by His Excellency the Governor
to wit. { of the State of South Australia.

(L.S.) C. W. M. NORRIE.

BY virtue of the provisions of the Crown Lands Act, 1929-1944, and all other enabling powers, I, the said Governor, with the advice and consent of the Executive Council, do hereby—

1. Constitute the lands comprised in the schedule hereto a new town, to be called the town of Padthaway, the boundaries whereof are defined in the said schedule.

2. Direct that this proclamation shall take effect from the day of publication thereof in the *Government Gazette*.

THE SCHEDULE.

Comprising all that portion of the hundred of Parsons, bounded as follows:—Commencing at a point on the north-eastern boundary of section 88 distant 100 links from the north-eastern corner of said section; thence east-north-easterly at right angles to said boundary for 300 links; south-south-easterly at right angles for 1,000 links; west-south-westerly at right angles for 550 links; north-north-westerly at right angles for 1,000 links; east-north-easterly at right angles for 250 links to the point of commencement.
